ANNOUNCEMENT OF ALLOTMENT RESULTS

SUMMARY

- Based on the Offer Price of HK\$0.50 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.003%, and Stock Exchange trading fee of 0.005%), the net proceeds from the Share Offer to be received by the Company and the Selling Shareholder, after deducting the underwriting commissions and estimated expenses payable by the Company and the Selling Shareholder in relation to the Share Offer, are estimated to be approximately HK\$48.1 million and HK\$14.9 million respectively. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.
- A total of 2,017 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 254,330,000 Public Offer Shares, representing approximately 15.9 times of the total number of 16,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. Due to the over-subscription under the Public Offer, the reallocation procedure as described in the paragraph headed “Structure of the Share Offer — The Public Offer — Reallocation” of the Prospectus has been applied and the number of Offer Shares allocated to the Public Offer has been increased to 48,000,000 Offer Shares (of which 32,000,000 Offer Shares have been reallocated from the Placing to the Public Offer), representing 30% of the total number of Offer Shares available under the Share Offer.
- The Placing Shares initially offered under the Placing have been moderately over-subscribed. The final number of Placing Shares allocated to the places under the Placing is 112,000,000 Offer Shares, representing 70% of the total number of the Offer Shares available under the Share Offer.

Based on the Offer Price of HK\$0.50 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%), the net proceeds from the Share Offer to be received by the Company and the Selling Shareholders, after deducting the underwriting commissions and estimated expenses payable by the Company and the Selling Shareholders in relation to the Share Offer, are estimated to be approximately HK\$48.1 million and HK\$14.9 million respectively. The Company intends to use the net proceeds from the Share Offer as follows:

- as to approximately 52.6%, or HK\$25.3 million, for purchase of materials as the Group increases the number and/or scale of projects the Group secures;
- as to approximately 16.6%, or HK\$8.0 million, for expansion of workforce to support the Group's business expansion, both at worksites (project supervisors, engineers, project in-charge and workers) and back office to support the Group's projects;
- as to approximately 10.4%, or HK\$5.0 million, for capital contribution to maintain the Group's existing shareholding percentage in YL, NEK and SRM;
- as to approximately 10.4%, or HK\$5.0 million, for expansion of the Group's market share through formation of new companies by capital contribution; and

At the close of the application lists at 12:00 noon on Thursday, 19 December 2013, a total of 2,017 valid applications pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total 254,330,000 Public Offer Shares, representing approximately 15.9 times of the total number of 16,000,000 Public Offer Shares initially available under the Public Offer, were received.

4 multiple applications or suspected multiple applications for a total of 4,205,000 Public Offer Shares which have been identified and rejected. 2 applications for a total of 205,000 Public Offer Shares have been rejected due to dishonoured cheque. No application for more than 100% of the Public Offer Shares initially available under the Public Offer, i.e., more than 16,000,000 Public Offer Shares (representing 10% of the total number of the Offer Shares available under the Share Offer), has been identified.

None of the Bookrunner, the Joint Lead Managers, the Co-Managers and the Underwriters or their respective associates and connected clients (as defined in Appendix 6 to the Listing Rules), has taken up any Offer Shares for its own benefit under the Share Offer. The Placing has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. None of the placees under the Placing will become a substantial Shareholder of the Company within the meaning of the Listing Rules after the Share Offer and that the number of shares in public hands will satisfy the minimum percentage requirement prescribed by Rule 8.08 of the Listing Rules.
